- ☐ Birth Certificate
- ☐ Passport
- ☐ Driver's License or ID Card
- ☐ Testimonial Character Letters – Job Offers / Narrative, Release Plan: Accepting Responsibility written, video, or both.

Medical Related Records and Prescriptions are in your PSR:

- ☐ All Medical Records, Hospital – Surgical – Pathology and Blood Lab Reports, Copies of X-Ray, MRI, CT, Ultrasound, PET Scans, EEG, EKG reports, and CDs, Prescriptions for Medications and Medical Devices.
- ☐ Prescriptions for medications, prosthetics, glasses (not metal), medical devices (CPAP), etc.

Copies of Diplomas, Certifications

- ☐ A Divorce decree
- ☐ Any **School diplomas**
- ☐ A Marriage Certificate
- ☐ Administrative Remedy Process
- ☐ Birth or baptismal certificate
- ☐ Draft registration card
- ☐ **Cash**; \$320 (\$370 in November and December), then use either Money Gram or Western Union for monthly deposits.
- ☐ Car Registration papers
- ☐ **Character Letters** of Recommendation
- ☐ **DETAINERS, UNRESOLVED CHARGES, OR IMMIGRATION STATUS**, **get these resolved ASAP**, as unresolved these could prohibit Early Release, or Even Your Freedom.
- ☐ Employment verification (pay stubs - ONLY FOR PSI)
- ☐ Income tax reports for the last three years (only for PSI - Not Self-Surrender)
- ☐ Immigration papers or passport
- ☐ **Legal papers and Medical Records in an envelope labeled "Legal Mail."**
- ☐ List of personal names (including phone numbers and addresses). Type on the back of a page from your court case and put it in an envelope labeled 'Legal' to take with you when you surrender.
- ☐ **Military disability information** (C-number), DD 214 Discharge Papers and Separation Documents
- ☐ **Naturalization papers**
Prescriptions for medications (recommended for 3-4 weeks, at worst they are discarded, and at best they are available for your use). When surrendering on weekends or holidays, the BOP may allow these to be used if not available from their pharmacy.
- ☐ **Power of Attorney and Living Will, Signed and Notarized**
- ☐ Present to the higher security facility if you are expecting a satellite camp. Expect to be placed into an isolation cell. I've been to both (it's not fun for the Unprepared), especially if your court's orders are not there.
- ☐ Proof of residence (rent receipts, property, Union, lodge, club cards, mortgage papers, etc.)
- ☐ Professional papers (**COPIES: Social Security Card, Driver's License, certificates, licenses**, or Seaman's papers permits)
- ☐ **If RDAP is eligible, please make sure it's on your judges Order.**
- ☐ Review form for completeness
- ☐ Psychology Programs are security level dependent, let's review before your Interview (PSI).
- ☐ Schedule your list of books you'd like to read to start being sent (2 at a time) 2 days before your arrival, and they will be delivered for the majority of your months incarcerated.
- ☐ Other requested information. _____
- ☐ Understand **The Financial Responsibility Program** – If You Have a Court-Ordered Financial Penalty.
- ☐ **Vaccines, bring proof or card.**
- ☐ Wedding band, religious necklace, Bible, under \$100 (No Stones).
- ☐ When driving to surrender, speeding is sometimes understood as three mph over the limit.
